FOLLOW UP INSPECTION FROM 2/20/24 IN WHICH THE WARE WASHER WAS UNABLE TO DISPENSE CHLORINE AND THE HOT POTENTIALLY HAZARDOUS FOOD WAS NOT AT 135F MINIMUM AT THE HOT HOLDING UNIT.

FINDINGS: THE WARE WASHER WAS SERVICED AND IT NOW DISPENSED CHLORINE AT 50 PPM. OK TO USE.

THE HOT POTENTIALLY HAZARDOUS FOOD IS NOW AT ABOVE 135F.
