## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

**Inspector Observations: There are 3 refrigerators/freezers that are in the store and not being used. [CA] If they are not being used then they must be removed.**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: The clean utensils are stored in containers that have food crumbs in it [CA] The clean utensils must be stored in clean containers.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: The floor is missing ties around the Coca Cola refrigerator. [CA] Repair the tile floor.**
