Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations:

Employee's Food Handler's Card were not available for review.

[Corrective Action] Employee's Food Handler's Cards shall be readily available for review.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations:

Old food residue observed on the refrigeration units and on cooking equipments.

[Corrective Action] Thoroughly clean and maintain clean. Create a daily, weekly and monthly cleaning schedule.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

Knife stored in the crevice between the tandoori oven and the work table.

[Corrective Action] Discontinue to store knives in the crevice. Store knives in a clean and dry area.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

1. Warped flooring in the service area. This is a trip hazard.

[Corrective Action] Maintain flooring in good condition. Repair to prevent trip hazard.

2. Damaged flooring in the kitchen area by the 3 compartment sink.

[Corrective Action] Maintain flooring in good condition.
