Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: *The hand sink was full of utensils and the soap and paper towel dispensers were empty. [CA] The soap and paper towel dispensers must be stocked and used for proper hand washing. The hand sink should be kept clear and accessible. [COS] The sink was cleared and the dispensers were refilled. According to the manager the sink is not used due to a leak. A leak was not observed during inspection. If the sink is not used due to a link it must be repaired.*

Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: *Observed several rodent droppings on the floor in one corner behind the hand sink. [CA] Take effective measures to eliminate rodents from inside the facility. Protect food from contamination. According to the manager the problem was taken care of and these must be old droppings. [COS] The droppings were swept up and the floor cleaned.*

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: *Observed the shelves and tables in the beverage area to be soiled with encrusted debris. [CA] Thoroughly clean the tables.*

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: *Observed some light bulbs out. [CA] Replace the lights that are out.*
