Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Prep area hand sink is out of order [CA] Fix the sink by 11/19/25/ You are schedule for an inspection on 11/19/25. There is no charge for this follow-up inspection. However, failure to comply will result in a second re-inspection charged at \$298 and for all related follow-up inspections thereafter.

Minor Violations

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: Employee washed hands with soap for 5 seconds [CA] All food employees shall thoroughly wash their hands and that portion of their arms exposed to direct food contact with soap and vigorously rub hands together to lather up for at least 10 to 15 seconds. They shall rinse hands with warm water followed by drying with paper towels. Employees shall pay attention to the areas underneath the fingernails and between the fingers when washing hands. – Corrected

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: No time markers placed on items on the counter [CA] When using time as public health control provide time marker - Corrected

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Lack quat test strip [CA] Provide quat test strip
