Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: The quat was at 100ppm in the towel bucket. [CA] It must be at 200ppm quat. [COS] It was corrected by employee.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floor has missing grout throughout and debris and water accumulation. [CA] Repair the floor grout to help stop the accumulation in between the tiles.
