Follow-up inspection for Major Violations K21 & K06.

Per the PIC, the water heater was repaired last night. Hot water was measured at the minimum required temperatures at the time of inspection (see measured observations). The handwash sink was observed accessible and provided with soap and paper towels in dispensers.

Payment for the issued 48hr notice was provided online at www.EHinfo.com and confirmation received. Be advised, the payment will post later next week due to the Monday holiday. The district specialist will review for completion and contact the permit holder if necessary.

The facility is ok to re-open. Green placard issued and posted.

Note: A review of the facility file shows pending required compliance for the permit condition issued in 2018. The district specialist will review the pending items with the permit holder and provide a comply-by date. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
