Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Hand soap dispenser inside restroom inoperable.

[CA] Handwashing facilities shall be equipped with handwashing cleanser and single-use sanitary towels in dispensers and shall be accessible at all times. [COS] PIC provided manual pump hand soap.

Minor Violations

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed butane stoves stored in kitchen of facility. PIC stated that it is only used to make food for employees to eat. No active cooking observed at time of inspection. [CA] All utensils and equipment shall be certified or classified for sanitation by an American National Standards Institute (ANSI) accredited certification program (e.g. NSF, UL EPH, UL Sanitation, CSA Sanitation, or ETL Sanitation). Remove butane stoves.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Heavy accumulation of dust and debris observed on walls and floors throughout kitchen. [CA] Walls and/or floors in food preparation area shall be kept clean.
