Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The sanitizer dispenser at the dish sink is at 0ppm quat. [CA] It must be at 200ppm quat.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to be soiled under and behind equipment. [CA] Thoroughly clean the floors. Observed the wall around the sinks under the caulk to be soiled. [CA] Remove and replace the soiled, deteriorated caulking.
