Comments and Observations

Major Violations

K09 - 8 Points - Improper cooling methods; 114002, 114002.1

Inspector Observations: *Observed several potentially hazardous foods that were improperly cooled located in the reach-in refrigerator (PHFs did not cool within proper time parameters). PHFs were found covered and in large pans. [CA] Ensure PHFs are properly cooled from 135F to 70F within 2 hours and from 70F to 41F within 4 hours. Use rapid cooling methods such as ice baths, ice paddles, smaller portions, frequent stirring, ice as an ingredient, and/or a blast chiller. [COS] PIC voluntarily discarded the food.*

Minor Violations

No minor violations were observed during this inspection.
