Observed the kitchen area, no observations of any vermin activity. Observed cockroach feces in some areas near food preparation sink.

FRP on the wall above food preparation sink has been repaired. Outlet covers are replaced. Any cracks or gaps on the walls, coving and outlets are sealed with caulking.

Continue to clean and sanitize the area thoroughly. Continue with professional pest control monthly.

Facility is reopened.
