## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations: Observed old rodent droppings on shelf in back storage area. [CA] Remove droppings and thoroughly clean and sanitize area. Recommend working with professional pest control. Seal all holes and gaps; set monitoring traps.**

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

**Inspector Observations: Restroom did not have a toilet paper dispenser; toilet paper stationed on back of toilet tank. [CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.**
