Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: *Front handwash sink did not have soap. Back handwash sink was not easily accessible (blocked by buckets of glaze, box of onion and a strainer in the basin of the handwash sink. [CA] Keep handwash stations stocked with soap and paper towels at all times. Keep handwash stations clear and accessible at all times. [COS] PIC provided soap at front handwash station and cleared the back handwash station.*

Minor Violations

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: *Observed cracked and broken tiles behind large mixer. [CA] Repair/replace tiles.*
