Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Accumulation of debris and residue on FRP panel adjacent to 3 compartment sink. FRP panel adjacent to 3 compartment sink in poor repair. Pooled water observed on grease trap. No sewage back-up observed after running the 3 compartment sink. Gaps and openings greater than 1/4 of an inch between FRP panel and tile wall.

[CA]: Maintain floors and walls clean and in good repair at all times.

[SA]: Staff removed pooled water during inspection. FRP panel and adjacent walls require further repair.
