Major Violations

K22 - 8 Points - Sewage and wastewater improperly disposed; 114197

Inspector Observations: Janitorial sink in laundry room is clogged and does not drain. Unable to discard mop water. Per PIC, they discard the mop water outside. [CA] Mop water shall be disposed of in the janitorial sink or toilet facility. [SA] A second janitorial sink located where the drinks/snacks are stored for the facility is available, has hot water and drains. Facility must use this mop sink to discard mop water until the main sink can be repaired.

A follow up inspection will occur on 05/23/2025 to ensure that the mop sink has been repaired/replaced.

Minor Violations

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: Warm water in women's restroom measured 69F and then dropped to 68F after allowing the water to run. [CA] Handwashing facilities equipped with a mixing valve that is not readily adjustable at the faucet, shall provide warm water at least 100°F, but not greater than 108°F.
