Inspector Observations: Snacks on the front counter are not protected from droplets [CA] Keep snack covered or provide a sneeze guard - Snacks were covered with tight-fitting lids for the containers

Inspector Observations: Labels are now provided for some of the items packaged on site [CA] Provide labels are all items packaged on site and offered to the customers
