Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations:

Dust accumulation on fan guard in the 3 door prep unit, filters in the exhaust hood, and fan vent above the freezer.

[Corrective Action] Routinely clean.

Mildew observed on the caulking at the 3 compartment sink. [Corrective Action] Routinely clean.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations:

Rubber seal/gasket observed in disrepair on the right door of the 3 door prep unit. [Corrective Action] Repair or replace the rubber seal/gasket.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations:

Observed a gap between the two filters in the exhaust hood. [Corrective Action] Ensure there is no gap in between the filters.

Missing light cover above the freezer. [Corrective Action] Replace the light cover.

Overall Comments:

Facility cooks pizzas for schools at 80% of the way then cools the pizza. The school facility then cooks it the rest of the way to sell to students.
