FOODS ARE PREPACKAGED AND DELIVERED FROM CHOICE LUNCH.

Facility uses Biodet as sanitizer to clean tables in between meal services. Measured Biodet, it contains Quat sanitizer at approx 400ppm. Ensure all chemical bottles are properly labeled.

NO VIOLATIONS OBSERVED AT TIME OF INSPECTION.
