Inspector Observations: At this time no employee has a current food safety certificate. [CA] At least one employee must have the food safety certificate.

Inspector Observations: Observed the warewashing machine to give 0ppm chlorine. [CA] The dish machine must be at 50ppm chlorine.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed black mildew like substance in the dish sink. [CA] Clean and sanitize the sinks.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Observed the back coffee room to have very dim lighting. [CA] Replace the out light bulbs in the room.
