- Observed cockroach droppings between wall edges on the left side of the 3 compartment sink, and cockroach droppings on shelving brackets above the 3 compartment sink.
- Clean and sanitize remaining areas with cockroach droppings, and seal cracks and crevices to prevent further harborage.
- Pest control service conducted on 5/14/2021 per pest control report.
- Continue to remove cardboard boxes from deliveries to prevent further harborage within the facility.
