### Major Violations

**Inspector Observations: Forks and spoons are placed tips up [CA] Store handles up to avoid tip contamination - Corrected**

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: Pizza oven hood shows buildup [CA] Clean the hood**
