Overall Comments:

This is a follow up inspection for the routine inspection conducted on 6/17/2024.

Observations:

K23: No evidence of vermin or a vermin infestation were observed. Facility was treated by EcoGaurd Pest Management verified by receipt invoice. Per receipt invoice, new glue traps were set, backpack sprayer was applied, and bait stations were set. Facility has cleaned the affected areas of dead cockroaches. Facility is okay to operate. Ensure to correct all pending violations within 2 weeks of the routine inspection report.

K41: Air gaps have been provided to the drainage pipes discharging into the floor sink. The floor sink was drained and cleaned with no standing water.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **7/2/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
