Major Violations

No major violations were observed during this inspection.

Inspector Observations: Chlorine measured at >200ppm in sanitizer bucket.

[CA] Maintain chemical solution 100 ppm (1Tbs of bleach (5.25%)/gal of water) for chlorine and 200 ppm (1 tbs of quaternary ammonium (10%)/2 gal of water) for quaternary ammonium.

[COS] Chlorine sanitizer was diluted to 100ppm.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Opened personal beverage stored in prep fridge next to food.

[CA] No person shall store open drinks near food prep.
