Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: At the handwash sink in the cooking area: observed the wall-mounted soap dispenser was not in good repair (dispensing soap was difficult).

Note: another handwash sink was located nearby.

[CA] Repair/replace soap dispenser and maintain in working order. Note: employee stated the facility has already ordered a new dispenser.

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: At the handwash sink in the cooking area: measured water temperature to be 83F.

[CA] Provide warm water (100F) at the handwash sink. Note: if the water temperature is not readily adjustable, the water temperature must not exceed 108F.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: The handwash sinks near the cookline and the 3-compartment sink were draining slowly.

[CA] Repair plumbing and maintain in good condition.
