*Follow recommendations from pest control company, such as not harboring cardboard, do not use over the counter treatments, and daily cleaning.*

*Observed contract for 6 months. Recommend monthly pest control management services for cockroaches and rodents.*

*Observed foods covered in dry storage room, clean daily.*

*Owner stated the rodent from complaint was found and killed.*

*Observed facility has been deep cleaned and no evidence of vermin observed.*

*Facility OK to reopen*
