Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Unable to provide a current food manger certification at the time of inspection.
[CA] Obtain a new food manger certification within 60-days.

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: Employee did not wash hands before putting on new gloves and wash touching monitor screens.
[CA] Properly wash hands with soap, warm water and dry using single use paper towels as required prior to putting on gloves.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Hand wash station next to 3-compartment sink is draining slowly at the time of inspection. Food maybe clogging drain.
[CA] Repair plumbing fixture and maintain in clean and good repair.
[SA] Additional hand wash station on site is fully stocked and operating properly.
