Overall Comments:

Food is received prepackaged frozen or cold held from Cupertino School District Central Kitchen. Food is then reheated or cold served while remaining prepackaged.

Leftover hot foods are discarded if not served during the lunch service.

A shared cart is placed out during the lunch service for student to place and share unwanted food items. Open foods on shared cart including fruits with edible skin will be discarded.

Daily temperature logs for refrigeration units are maintained at the facility.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **10/31/2025**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
