Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: One of the cooks does not have a food handler card available. [CA] The food handler cards must be available upon request.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: There was not any soap in the first hand washing sink. [CA] Be sure the soap dispensers at each hand sink are filled.

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Observed a spray bottle with liquid on the floor under the far hand sink. [CA] Each spray bottle must be labeled with the contents. [COS] The bottle was emptied by the owner.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The warewashing sink had no chlorine sanitizer when tested. [CA] The dish washing machine must be at 50ppm chlorine. [SA] Use the 3 compartment sink to wash, rinse, sanitize all dishes, equipment, and utensils.
