Follow-up inspection for conditional pass due to lack of hot water and inadequate handwash facilities.

The following violations was corrected:

K06M - Inadequate handwash facilities

- At the handwash station, observed a roll of paper towels provided and a bottle of pump hand soap.
- Operator to bring more stock of paper towel rolls that fit in paper towel dispenser.

K21M - Lack of hot water

- Measured hot water at the 3 compartment sink at 110F.
- Measured hot water in the restroom at 118F.
- Operator to ensure hot water reaches 120F for 3 compartment sink, prep sink, and mop sinks, and hot water reaches 100F-108F at all handwash stations.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than 12/28/2022. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
