Major Violations

K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Two live cockroaches observed on wooden board at the bottom of the food preparation table next to the preparation refrigerators by the entrance into the kitchen. 5+ live cockroaches of various life stages observed on wall behind the grease collector under the ware wash machine. One live adult cockroach carrying egg sac and one nymph observed crawling on grease collector bin.

Follow-up By 09/20/2022

Facility has pest control servicing facility. Reports were available for 1/27/2022, 3/30/2022, 6/22/2022, 7/31/2022, 8/28/2022. Pest control reports showed no findings for pest activity and minor structural issues to prevent harboring of pest.

[CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation of the food facility immediately.
