## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

#### Inspector Observations:

**Heavy dust accumulation on the fan guard in the restroom.**

**[Corrective Action] Thoroughly clean and maintain clean.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

#### Inspector Observations:

**Facility lack chlorine test strips.**

**[Corrective Action] Provide chlorine test strips to be able to monitor chlorine sanitizer concentration in the dishwasher.**

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

#### Inspector Observations:

**Toilet paper not dispensed from the toilet paper dispenser.**

**[Corrective Action] Ensure toilet paper is dispensed from the toilet paper dispenser.**
