### Major Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

**Inspector Observations: 1. Dust build up noted within the fan guards of the walk in refrigeration.**

**[CA] Nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue, and other debris.**

**2. Mold like substance growing within the caulking around the 3-Compartment sink.**
