Major Violations

No major violations were observed during this inspection.

Minor Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations:

Wire shelving has an accumulation of dust.

[CA] Nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue, and other debris.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

There is dust and food debris buildup observed on the wall underneath/behind the 3 compartment sink, and on the wall behind the oven.

[CA] Walls in food preparation area shall be kept clean.

**** Approved labeling observed on prepackaged cream cheeses.***


