Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: 1. Hand wash station in the back prep area is missing paper towels inside of dispenser at the time of inspection.

[CA] Hand wash stations must be fully stocked at all times.

2. Hand wash station within restroom has a paper towel dispenser that is not operational at the time of inspection. Dispenser is blinking and batteries might be dead.

[CA] Hand wash station must be fully stocked at all times. Change battery within dispenser.

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: Sanitizer within the 3-compartment sink was measured at 100PPM at the time of inspection.

[CA] Maintain chemical solution for manual warewashing at 100 ppm (1Tbs of bleach (5.25%)/gal of water) for chlorine and 200 ppm (1 tbs of quaternary ammonium (10%)/2 gal of water) for quaternary ammonium.

[COS] PIC changed sanitizer within compartment; re-measured at 200PPM.

Needs Improvement - Adequate handwash facilities: supplied or accessible.

Needs Improvement - Food contact surfaces clean, sanitized.

Facility has obtained two new reach ins (Freezer/refrigeration). Both units are commercial grade (Ikon).
